We have grown from a small grassroots group running 4 programs a year to delivering 36 programs annually that reach out to over 600 children and youth a year, providing unique professional development and network opportunities for artists, a literacy program, an international short film festival, a respected juried art show and community projects like Art on the Move, Brass in the Grass and most recently our 1812 theatre collaboration. All this



with limited dollars, limited staff, amazing volunteers and community partners that share our passion for creating arts opportunities in this neighbourhood. Co-produced by Lakeshore Arts and Sirius Theatrical Company with support from the Government of Canada. This community collaboration was a 14 month undertaking including free workshops and engaged emerging thespians who performed a script written by artistic director, Heather Dick.

Culture Days

In September, for 3 days, the Lakeshore became a creative and artistic HUB of cultural activity. Lakeshore Arts acted as the producer and galvanized over 14 artists, art organizations and businesses to create an array of free, interactive artistic and creative activities. The events ranged from Bollywood Dance lesson to pottery lesson; yoga instruction to tasting Portuguese cheese.



Public Art

Fowl Play, our newest mural in Etobicoke-lakeshore

With support from StreetART Toronto, artists Patrick Thompson and Alexa Hatanaka mentored two local youth to create a unique underwater view of aquatic lake life on the side of Birds and Beans café which faces into the Amos Waites Park. This public art campaign is part of our commitment to assist with the revitalization of our community and providing meaningful and applicable skills development for our youth.

Photography Camp

Now in its second year, we partnered with Lakeshore Collegiate Institute to deliver an amazing camp that teaches both digital and traditional photography techniques to youth ages 11-14. The campers built their own pinhole cameras, developing their images in a fully equipped darkroom and also had access to a fully equipped MacLab in LCI's CyberArts studio, learning Photoshop skills and creating digital works of art!

Shazaam! Literacy through the Arts

Celebrating its 8th year at Second Street JMS, this programs incorporates literacy, poetry, spoken word, illustration and new media as modes of delivery and expression. It builds on values of friendship, family and loyalty and respect.

YAM

For 8 years, our YAM program has provided a safe and creative environment to explore a variety of art forms and work directly with professional artists. This bi-monthly arts drop in program is programmed by a youth-led committee consisting of four dedicated members who organized the entire year. Workshops included, Stop Motion Animation (premiered at the Lakeshorts International Film Festival), Special Effects Make-up, Stenciling, Theatre Improv, and Zumba.

ARTiculate

A free 2-week summer leadership in the arts program. Professional artist facilitators lead workshops in a variety of disciplines including sculpture, breakdance, metal working, animation and creative writing plus behind the scene tours of Harbourfront Centre, Canadian Stage Company's The Dream in High Park and The Christian Louboutin Exhibit at the Design Exchange. A leadership component allows the youth to develop and deliver an arts program to 60 children in 3 local libraries over a two-day period.

Connecting the Dots

A lunchtime speaker and demo series for high school students that featured emerging professional artists speaking about their path from high school to career. The artist speakers worked in non-traditional art practices, exposing students to alternative careers in the arts including animation, furniture design, mural art, special effects makeup and sound designer.

Lakeshorts Future Filmmakers Intensive

As part of our arts education mandate, LFFI was established in 2012 due to the generosity of Robert Murray and Scotiabank GBM. Described as "hopping aboard the train of making a professional film", and created by artistic director Michelle Nolden, six local students were mentored by industry experts from writing, directing, cinematography to make-up and marketing over five amazing and long days. The outcome was Flaked, a 5 minute film that premiered to great accolades at both screenings at the Festival.

AUDITOR'S REPORT

I have audited the accompanying financial statements of Lakeshore Arts Committee which comprise the statement of financial position as at July 31, 2013 and the statements of operations and changes in net assets and statement of cash flows for the year then ended, and a summary of significant accounting policies and other explanatory information.

Management is responsible for the preparation and fair presentation of these financial statements in accordance with Canadian generally accepted accounting principles for not-for-profit organizations, and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

My responsibility is to express an opinion on these financial statements based on my audit. I conducted my audit in accordance with Canadian generally accepted auditing standards. Those standards require that I comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing

an opinion on the effectiveness of the entity's internal control. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by management, as well as evaluating the overall presentation of the financial statements.

I believe that the audit evidence I have obtained in my audit is sufficient and appropriate to provide a basis for my qualified audit opinion.

In common with many charitable organizations, Lakeshore Arts Committee derives a portion of its income from donations and proceeds from fundraising, the completeness of which is not susceptible of satisfactory audit verification. Accordingly, my verification of these revenues was limited to the amounts recorded in the records of the organization and I was not able to determine whether any adjustments might be necessary to revenues, excess of revenues over expenses, assets, and unrestricted net assets.

In my opinion, except for the effect of adjustments, if any, which I might have determined to be necessary had I been able to satisfy myself concerning the completeness of the revenues referred to in the preceding paragraph, these financial statements present fairly, in all material respects, the financial position of Lakeshore Arts Committee as at July 31, 2012 and the results of its operations and cash flows for the year ended in accordance with Canadian generally accepted accounting principles for not-for-profit organizations.

TREASURER'S REPORT

I have great pleasure in presenting the treasurer's report for the year ending 31 July 2013. The financial statements, have been audited by Jeffrey D. Milgram, Chartered Accountant/Licensed Public Accountant. The Board of Directors of Lakeshore Arts have reviewed the statements and recommended their presentation for approval to the membership at the AGM.


Lakeshore Arts attracts a diversified stream of revenue, and its expenditures are consistent overall with other local arts service organizations, including Arts Etobicoke, Urban Arts, and Scarborough Arts.

Despite identifying and securing several new sources of funding, in the fiscal year ending July 2013, Lakeshore Arts had a deficit of \$25K. The organization maintained the same level of programming offered in prior years without the support of the Ontario Trillium Foundation monies which it had relied on in the past. The potential for the deficit was identified early in the year which lead to the formation of a Finance Committee which meets quarterly. This committee has developed and begun to implement a deficit reduction plan that would see the current deficit leminated by 31 July 2015. Lakeshore Arts was a recipient of a COMPASS grant through the Ontario Arts Council with which it is creating a three year strategic plan including the formation of a Resource Development Committee to focus new sources of revenue and working to create a cash reserve. We have also secured a new three year Trillium grant for our youth initiatives this past July.

Lakeshore Arts continues to play a key role in advocating for the community arts sector at all levels of government and works diligently in encouraging the City Council to honour their \$25 per capita arts funding commitment.

Once again it must be stressed that the current income levels are, of course, made possible only by the continued efforts of the staff of Lakeshore Arts, with support from the membership - both within and outside the Board of Directors.

Art on the Move/Luminato

Arts Etobicoke and Lakeshore Arts in association with Luminato created an art wrapped vehicle launched at the opening of Luminato at David Pecault Square. Working with grades 6, 7, and 8 students from the Karen Kain School of the Arts and artist and arts educator, Melissa McGrath, the youth focused on collaborative 'portraits' illustrating the guiding principles of the Festival - transformation, collaboration, accessibility and diversity. The vehicle was also showcased at local venues including Montgomery's Inn, Neilson Park Creative Centre and the Assembly Hall.

Art on the Move/ Albion Boys and Girls Club

North Etobicoke's Albion Boys and Girls club collaborated with artist Graham Curry to create artwork to adorn the van shared by themselves and Albion Neighbourhood Services. The entire project was documented with still photography and a video documentary of the process by youth from MicroSkills located at the Rexdale Hub.
